Acknowledgment of Risk, Acceptance of Responsibility, Release of Liability

This document affects your legal rights. You must read and understand it before signing.

I also agree to pay for any damages caused to others (including attorneys' fees and costs) if they are injured or otherwise damaged due to any negligent actions. My participation in this activity is purely voluntary: no one is forcing me to participate, and I elect to participate in spite of the known and unknown risks.

RELEASE: In consideration of the services and/or property provided, I, for myself and any minor children for which I am the parent, legal guardian, or otherwise

responsible, heirs, personal representatives, or assigns do hereby release BUNGALOW OUTFITTERS, LLC, its principals, directors, officers, agents, and volunteers from any liability and waive any claim for damages arising from any cause whatsoever (except that which is gross negligence). I further agree to reimburse you for all attorney fees and costs should I bring a legal action against you and lose.
